The **Chairman, High Level Procurement Committee (HLPC) on behalf of Ceylon Petroleum Corporation (CPC)** invites sealed Bids from eligible bidders, who have carried out infrastructure development and construction works in Oil & Gas industry for EPC/Turnkey Projects to perform design, procurement, construction, testing & commissioning works, for the project “Construction of a Jet A-1 transfer pipeline from Muthurajawela to BIA Katunayake and construction of Jet A-1 storage tanks and associated facilities with modifications to the existing terminal facility at Muthurajawela”
2. This turnkey contract shall cover detailed engineering design and fabrication drawings, supply of equipment and materials, installation, inspection, mechanical testing, internal & external painting, insulation, obtaining third party inspector’s approval, pre-commissioning, start-up, commissioning, delivery and operation of a Tank Farm and a piping interconnection of the Tank farm at Muthurajawela with the aviation fueling terminal located at Bandaranaike International Airport (BIA), Katunayake, Sri Lanka. The Tank Farm shall be the main storage unit for receiving Jet A-1 fuel from ocean tankers, storage and transportation of Jet A-1 fuel through a 10-inch pipeline to BIA aviation fueling terminal at Katunayake, Sri Lanka.

- i) *Any Foreign Contractor who wishes to carry out any "Construction Contract" as the main/lead party upon the succeeding its bid, shall obtain a Temporary Registration Certificate for Foreign Contractor; as per the procedure stipulated by Construction Industry Development Authority (CIDA) of Sri Lanka under the Extraordinary Gazette bearing No. 2085/19 dated 23.08.2018 using the application No. CIDA/ID/21.*
