1. The Democratic Socialist Republic of Sri Lanka has applied for financing from the Asian Development Bank (ADB) towards the cost of Power System Strengthening and Renewable Energy Integration Project (PSSREIP). Part of this financing will be used for payment under the contract named above. Bidding is open to Bidders from eligible source countries of the ADB.

2. The **National System Operator Private Limited** (“the Employer”), invites sealed bids from eligible Bidders for the:

Integration of Renewable Energy Management System and NSCC SCADA/EMS Modernization.

Scope of the Project:

The project includes the design, supply, installation, testing, and commissioning of the SCADA/EMS at the National System Control Centre (NSCC), National System Operator Private Limited, including integration of the Renewable Energy Management System (REMS) with existing grid infrastructure. The scope further covers software configuration, operator training, documentation, and maintenance support to ensure secure and reliable system operation.

Completion period is **545 days** (from the Contract Effective Date).

3. **Open Competitive Bidding (OCB)** will be conducted in accordance with ADB’s Single-Stage: Two-Envelope bidding procedure and is open to all bidders from eligible source countries as described in the Bidding Documents.

4. Only eligible Bidders with the following key qualifications should participate in this bidding:

- Bidders are required to have satisfactory Participation as a contractor, Joint Venture partner, or Subcontractor, in at least **two** contracts that have been satisfactorily and substantially completed within the last **ten (10)** years and that are similar to the proposed contract, where the value of the Bidder’s participation under each contract exceeds **US \$ 6 million**. The similarity of the Bidder’s participation shall be based on physical size, nature of works, complexity, methods, technology, or other characteristics as described in Section 6 (Employer’s Requirements) of the bidding documents.
- Bidder shall have a minimum average annual turnover of **US \$ 16 million** calculated as total certified payments received for contracts in progress or completed, within the last **three (03) years**.

6. To purchase the Bidding Documents, eligible Bidders should:

- Visit the office of the Director (System Control) at address indicated above between 09:00 hours and 15:00 hours on working days until the bid submission deadline and pay a non-refundable fee of Sri Lanka Rupees One Hundred Thousand (LKR 100,000.00) by cash or in the form of bank draft written in favor of the Chief Executive Officer, National System Operator Private Limited. *(Online or electronic fund transfers will not be accepted.)*

OR

- Request for delivery by sending a written application to the address above requesting the bidding documents for **Integration of Renewable Energy Management System and NSCC SCADA/EMS Modernization**. The application must include a bank draft in favour of Chief Executive Officer, National System Operator Private Limited, for the amount of LKR One Hundred Five Thousand (LKR 105,000.00) for domestic delivery or US Dollars Seven Hundred and Fifty (USD 750) for overseas delivery. *(Online or electronic fund transfers will not be accepted.)* No liability will be accepted for loss or late delivery.

7. The Pre-Bid meeting will be held on **23-04-2026 at 10:00 hours** at the Office of the Director (System Control), National System Operator Private Limited, No. 80, Parliament Road, Pelawatta, Battaramulla, Sri Lanka. The meeting will be conducted as a physical meeting, and all participants are requested to attend in person to facilitate a clear understanding of the project requirements.

8. Bid Security

The Bidder shall furnish a bid security issued by bank using the form included in Section 4 (Bidding Forms). The amount and currency of the bid security shall be **LKR 74 million or US\$ 240,000** with the validity period **208 days**.

Bid Security shall be;

(a) An unconditional bank guarantee issued by a licensed commercial bank approved by the Central Bank of Sri Lanka and operating in Sri Lanka or issued by a bank based in another country and certified by a licensed commercial bank approved by the Central Bank of Sri Lanka and operating in Sri Lanka.

Note: An irrevocable letter of credit, a cashier's certified cheque or a swift message in the form of MT760 are not acceptable.

Technical bids will be publicly opened on 14th May 2026 at 10:15 hours (Local Time) in the presence of Bidders designated representatives at the Office of the Director (System Control), National System Operator Private Limited, No. 80, Parliament Road, Pelawatta, Battaramulla, Sri Lanka., whereas the Financial Bids shall remain sealed and unopened and shall be placed locked. The Financial Bids of only Technically Responsive and Qualified Bidders shall be opened after Technical Bid Evaluation, whereas the Financial Bids of those Bidders whose Technical Bids are not responsive and qualified shall be returned unopened after the contract is awarded.

10. The Employer will not be responsible for any cost or expenses incurred by Bidders in connection with the preparation, attending Pre-Bid meeting and delivery of bids.
